WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 for change in production activity.

AND WHEREAS, As per the MPC Board's circular dated 25/08/2025, amendment in consent shall be considered only for - (a) Typographical or clerical errors in the consent issued (b) Change in name of the industry (subject to supporting documentary evidence) (c) Change in disposal path of hazardous waste for pre-processing or co-processing, as per the policy of the Board.

AND WHEREAS, your application for amendment in consent for change in activity cannot be considered.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above reasons. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
