AND WHEREAS, the Board office has granted Renewal of Consent to Operate vide dated 12/03/2026 reference (1). You have submitted application for change in quantity, validity, Hazardous waste and Non-Hazardous waste.

AND WHEREAS, your amendment application is not in accordance with the Board's Circular dated 25.08.2025 as above ref.(2)
