WHEREAS, this office is in receipt of your application for grant of Consent to Amendment under section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, Board has granted Consent and Bio-Medical Waste Authorization on 09/08/2025 for 1 no. of bed vide reference (1) above and you have applied for amendment for change in no. of beds i.e. increase in no. of beds for 10 no. of beds.

AND WHEREAS, you are requested to apply for consent to establish/operate for expansion with required documents/requisite consent fees. The Board is unable to take decision about grant of consent due to improper submission of application.

In view of above, your application for grant of Consent to Amendment is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances.
