WHEREAS, Ministry of Environment and Forests, Govt. of India has notified, Water (Prevention and Control of Pollution), Act, 1974 for prevention and control of water pollution and the maintaining or restoring of wholesomeness of water and Air (Prevention and Control of Pollution), Act, 1981 for prevention, control and abatement of air pollution.

AND WHEREAS, Central Pollution Control Board on 04.06.2014 has issued Directions under section 18 (1) (b) of Water (Prevention and control of Pollution) Act, 1974 regarding classification of Industries into Red, Orange and Green in which Health Care Establishment are covered under the regime of Consent.

AND WHEREAS, Ministry of Environment and Forests, Govt. of India in exercise of the powers conferred u/s. 6,8 & 25 of Environment (Protection) Act, 1986 has notified the Bio-Medical Waste Management Rules, 2016, and amended Rules, 2018 which is subsequently amended from time to time.

AND WHEREAS, Maharashtra Pollution Control Board is the Prescribed Authority for the enforcement of Bio-Medical Waste Management Rules, 2016, as amended from time to time.

AND WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to Establish (Expansion) and Biomedical Waste Authorization and from SRO-Nashik on 15-10-2025.

AND WHEREAS, The Board has issued a circular dated 25/08/2025 regarding "Applications for Amendment in Consent." As per the said circular, the following reasons shall be considered valid for submission of amendment applications in Consent.

1. Typographical or clerical errors in the consent issued to the industry.
2. Change in the name of the industry (subject to supporting documentary evidence).
3. Change in the disposal path of hazardous waste for pre-processing or co-processing, as per the policy of the Board.

AND WHEREAS, your application was discussed in 8th CC meeting held on 11/09/2025, wherein it was decided to issue SCN for refusal to call justification for changing capacity from standby to working. Accordingly, SCN for refusal was issued on 25/09/2025 and you have submitted reply on 01/10/2025.

AND WHEREAS, your application was discussed in 10th CC meeting held on 04/11/2025 wherein it was decided to refuse the amendment application as it does not meet the criteria specified for considering amendment application as per Board circular dated 25/08/2025.

NOW THEREFORE, your application for grant of amendment in Combined Consent to Establish(Expansion) & BMW Authorization under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and the Biomedical Waste Management Rules, 2016 is hereby refused, which please be noted.
