WHEREAS, this office is in receipt of your application for grant of Consent to Operate under section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016. The Sub Regional Officer Jalna had reported that your earlier application for CCA (C to O) vide UAN MPCB-CONSENT-0000262833 was refused on 03/12/2025 due to non submission reply of not submitted reply & not paid penal fees. Hence, the said application for amendment is refused.

AND WHEREAS, Board Circular regarding application for amendment in consent dated 25.08.2025 your application is hereby refused.

In view of above, considering the above noncompliance, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981. You are hereby directed not to take any effective steps towards operation of the unit without permission of the Board, else Board will initiate legal action as per the provisions of Environmental enactments.

If you are aggrieved by this order, you may prefer on appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 days' time from the date of receipt of this letter.
