- The applicant shall not use plastic and plastic packaging material, which are banned as per the provision of Maharashtra Plastic & Thermocol Products (Manufacture, Usage, Sale, Transport, and Handling & Storage) Notification 2018 and further amendments and also comply with the provisions of the Maharashtra Plastic Waste Management Rules, 2016 and further amendments
- The applicant shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH), in case of store /handle/ process the Hazardous Chemicals.
- The applicant shall not carried out any expansion of your unit without prior permission from the Maharashtra Pollution Control Board and shall not generate any trade effluent from their existing activities, else this consent stand cancelled automatically.
- This consent is issued with overriding effect on earlier Consent to Operate granted by the Board vide no. Consent No. Format1.0/RO/UAN No.0000160821/CR/2308001025 dtd. 17.08.2023 valid upto 31.03.2027
