- This consent should not be construed as exemption from obtaining necessary NOC/permission from any other Government authorities.
- The applicant shall make an application for renewal of consent 120 days prior to date of expiry of the consent. (Operate/Renewal).
- This consent shall be consider cancelled if industry violates the various environmental laws, rules and regulations.
- Industry shall comply with the EIA notification, dtd. 14.09.2006 and Amendments thereto and consent shall treat as cancelled if industry violates the same.
- The consent shall be issued subject to comply with CPCB's letter dated 25.10.2019 regarding mechanism for Environment Management of Critically and Severely Polluted Areas and to comply for consideration of activities/projects in such areas in compliance to Hon'ble NGT Order dated 23.8.2019 in the matter O.A. no. 1038/2018.
- This consent is issued subject to obtain permission/NOC from Central Ground Water Authority (CGWA) and MIDC in your premises for the use of ground water if any.
- The Industry shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH).
- Other conditions mentioned in the existing Consent remain unchanged.
