WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, Your application vide reference no-1 was discussed in Consent committee meeting and decided to refuse the application of amendment in issued consent.

1. Your requested to waive the condition of Environmental Clearance in the issued consent to establish not consider as you fail to submit the documents from Environmental Department, i.e. E.C. is not applicable.
2. Your application is not fit for amendment as per the board circular for amendment in consent issued dated-25.08.2025

AND WHEREAS, In view of above and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Amendment in obtained Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
