AND WHEREAS, you have applied for Consent to Establish vide UAN vide UAN MPCB-CONSENT-0000293614, dated 02/07/2026. This application was for HDPE containers in Green SSI category. Scrutiny letter was issued on 10/07/2026 & you have fail to submit reply to the same & hence application was refused by Board vide letter dated 23/07/2026. Now instead of replying to scrutiny on document section of same application on time, you have submitted amendment application.

AND WHEREAS, amendment application is not applicable for scrutiny reply & you have to reapply to obtained Consent to Establish with all relevant documents.
