WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, Board office has issued show cause notice vide reference (2) above for submission of misleading information regarding Bio Medical waste generation & disposal thereof, water budget, non-submission BMW annual report & Environment statement.

AND WHEREAS, Board office has issued show cause notice vide reference (2) above for following non compliances. 1) The information submitted about capital investment / gross block as cost of land & building @ 280 sq. mtr. Is shown as Rs. 219 Lakh wherein cost of land is shown as Rs. 1.55 Cr. But, it is not representative as cost of land purchased through sale deed in year 2014 is Rs. 3.09 Cr. 2) The information submitted about water budget, waste water generation is not representative as water bill shows water consumption up to 7000 ltr per day 3) You have not submitted authentic information pertaining to Bio medical waste generation & disposal thereof

AND WHEREAS, you have uploaded information pertaining to capital investment / gross block certified by CA, water bills but, not submitted details of water budget, waste water generation, Bio medical waste generation & disposal thereof, BMW annual report & Environment statement

AND WHEREAS, You have failed to submit desired information despite of the sufficient and reasonable opportunity given for the submission of the same.

AND WHEREAS, in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
