WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016. The Sub Regional Officer's Latur had reported that you applied for enhance in quantity of consumption of water from 172 CMD to 300 CMD.

AND WHERE AND WHEREAS, As per Board Circular dated 25.08.2025 you case cannot be consider for change in enhance in quantity of consumption of water from 172 CMD to 300 CMD hence your Amm dement consent application hereby refused.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances.
