WHEREAS, this office is in receipt of your application for grant of Consent to Amendment under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, As per online office record Board has granted Consent to Operate on 10/05/2023 for the mfg. of Plastics Water Tanks - 500000 Lit/Day & UPVC Pipes -10 M/Day valid upto 31/03/2035 for CI of Rs.44.8094 Crs. vide reference (1) above and you have applied for amendment for change in capital investment & add DG set. You have decreased your capital investment as 21 Lacs.

AND WHEREAS, your application for grant of Consent to Amendment can not considered as you have not submitted correct/required documents with clarification for decrease in CI. The Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
