WHEREAS, this office is in receipt of your application for grant of Consent Amendment Application Unique Number : MPCB-CONSENT\_AMMENDMENT-0000018790 under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.
