Subject: Consultant's Report on Geological and Hydrological Investigations for Stone Quarry Projects

Geological and hydrological investigations are mandatory for obtaining Environmental Clearance (EC) for proposed stone quarry lands. However, it has been observed that many proposals are reaching the State Expert Appraisal Committee (SEAC) for appraisal without these critical investigations.

Accredited consultants, who typically have sectoral Functional Area Experts (FAEs) on their teams for project-specific studies. It is expected to ensure that the following parameters/aspects are thoroughly investigated and included in the report:

- 1. Geological structures
- 2. Land slope and elevation.
- 3. Slope information, especially in hilly terrains (e.g., <1:5 or >1:5).
- 4. Slope stability assessment for hilly area.
- 5. Monsoon groundwater level data.
- 6. Feasibility assessment of the stone quarry.

Above investigations are crucial for a comprehensive appraisal of stone quarry proposals and all Consultants must submit a study report with their recommendations.
